Spectrum Release Plan for 2018 – 2020 (Updated version as at 26 July 2018)

Introduction

In accordance with the Radio Spectrum Policy Framework announced by the Government in April 2007, the Communications Authority ("CA") will publish a spectrum release plan ("SRP") to inform the industry of the potential supply of radio spectrum for the following three years. The SRP is updated every year on a rolling basis, or as required, taking into account the latest developments. Details of the updated SRP for 2018 – 2020 are listed below. It includes potential supply of spectrum which may be made available through open bidding, tendering process or other appropriate means.

Notes:

- "Earliest release date" refers to the earliest date when the spectrum concerned is expected to be available for release to the market through auction, tendering or other appropriate means, subject to the outcome of consultation and enactment of the relevant subsidiary legislation. It does not necessarily refer to the actual date of spectrum assignment.
- According to the decision of the CA announced on 19 December 2017 (see https://www.coms-auth.hk/filemanager/statement/en/upload/429/ca_statements20171219 en.pdf), the right of first refusal for 80 MHz of spectrum in frequency bands 1720 1730 MHz, 1740 1770 MHz, 1815 1825 MHz and 1835 1865 MHz ("RFR Spectrum") was offered to the incumbent spectrum assignees administratively in July 2018, while the auction of the remaining spectrum (together with any spectrum that may become available due to the decision of any incumbent spectrum assignee not to exercise their right of first refusal to take up the RFR Spectrum) will be conducted around end 2018.
- [3] Two rounds of public consultation were completed in 2016 and 2017 respectively.
- The invitation for Expression of Interest was issued in December 2017 for submissions within six weeks. The public consultation on proposed allocation of the 26 GHz and 28 GHz bands to mobile service and the associated arrangements for spectrum assignment and spectrum utilisation fee was launched in July 2018.
- The public consultation on the arrangements for spectrum allocation and assignment as well as spectrum utilisation fee will be conducted in Q3 2018.
- The public consultation on spectrum re-allocation was completed in September 2017. The CA issued a statement in March 2018 promulgating its decision to change the allocation of radio spectrum in the 3.4 3.7 GHz band from fixed satellite service to mobile service for the provision of public mobile telecommunications services with effect from 1 April 2020. The public consultation on the arrangements for the spectrum assignment and related spectrum utilisation fee was conducted between May and June 2018.

This SRP is for information of the industry and the public. Publication of the SRP does not constitute any allocation or assignment of the spectrum. The SRP does not bind the CA in exercise of its discretion in the actual spectrum allocation and assignment. The CA will conduct separate consultation

exercises before exercising its powers under sections 32H(2)(a) and (b) and 32I(1) of the Telecommunications Ordinance (Cap 106) as is reasonable in all the circumstances of the case. In making a decision on spectrum allocation and/or assignment, the CA will also take into account all relevant matters of the case. The CA is entitled to depart or deviate from the SRP where the circumstances so warrant. The SRP is subject to annual review and may from time to time be amended, as and when it is considered necessary in the light of latest developments.
