

## 申請海上無線電(本地船隻)牌照 APPLICATION FOR MARITIME RADIO (LOCAL VESSEL) LICENCE

填寫本申請表格前，請閱讀以下資料和在通訊事務管理局（通訊局）網頁(<http://www.coms-auth.hk>) 的「海上無線電(本地船隻)牌照申請指引」。

1. 擬在本地船隻如躉船、拖船、領港船、渡輪、石油運輸船、遊樂船隻、漁船等或在與遊樂船隻進行無線電通訊而設置的海岸電台內管有或使用無線電通訊電台的人士，必須先領有海上無線電(本地船隻)牌照。
2. 海上無線電(本地船隻)牌照年費為港幣150元。
3. 申請時需要提交以下證明文件副本。
  - (a) 船隻電台 –
    - (i) 香港海事處發出的 (a) 擁有權證明書及運作牌照（如船隻未取得運作牌照，閒置船隻允許書亦可被接納），或 (b) 本地船隻領牌前原則上批准通知書（如船隻未取得擁有權證明書及運作牌照）。就以 (b) 提交的申請，當獲取海上無線電(本地船隻)牌照後，持牌人須向管理局補交回其後取得的擁有權證明書及運作牌照的影印本。如持牌人未能遵守或符合這項規定，管理局可能會採取行動，包括不為該牌照續期；
    - (ii) 船東的香港身份證或護照；
    - (iii) 如船隻屬公司擁有：商業登記證及公司註冊證明書（如適用）；
    - (iv) 擬作公眾通訊之用的電台：證明已與通訊事務管理局辦公室（通訊辦）認可帳務機構訂立合約以繳付所有通訊費用的文件（有關認可的電訊帳務機構名單，請參閱資料便覽 [OFCA I236](#)）；及
    - (v) 負責操作組成該船隻電台無線電設備的人士的無線電操作員證書，（如適用）。
  - (b) 海岸電台 –
    - (i) 設置該電台的遊艇會、遊艇停泊處等的商業登記證及公司註冊證明書（如適用）；及
    - (ii) 負責操作組成該海岸電台無線電設備的人士的無線電操作員證書，（如適用）。
  - (c) 便攜式電台 –
    - (i) 申請人的香港身份證或護照；及
    - (ii) 申請人的無線電操作員證書。
4. 填妥的申請表格，請以下列任何一種方式提交。

6. 接受以現金、支票或「易辦事」付款。如以支票付款，請劃線註明抬頭人為「通訊事務管理局辦公室」。付款辦法 –
  - (a) 如親自前往通訊辦牌照組，接受以現金、劃線支票或「易辦事」付款。
  - (b) 如經互聯網、郵遞、傳真或電郵提交申請表格，可郵寄劃線支票至通訊辦牌照組。
7. 如申請獲得批准，通訊辦會將牌照以郵遞方式寄回給你。
8. 辦公時間為星期一至五上午八時三十分至下午十二時三十分及下午一時三十分至下午五時四十五分。星期六、日及公眾假期休息。

Please read the information below and the “Guidelines on Application for Maritime Radio (Local Vessel) Licence” in the Communications Authority’s (CA’s) website (<http://www.coms-auth.hk>) before completing this application form.

1. A Maritime Radio (Local Vessel) Licence should be obtained before a person possesses or uses a maritime radiocommunication station on board a local vessel, such as barge, tug, pilot boat, ferry, oil carrier, pleasure vessel, fishing vessel, etc. or at a shore station established for radiocommunications with pleasure vessels.
2. The annual licence fee for a Maritime Radio (Local Vessel) Licence is HK\$150.
3. Photocopies of the following documents are required to support this application.
  - (a) Ship station –
    - (i) Hong Kong Marine Department issued (a) Certificate of Ownership and Operating Licence (or Permission for a Laid-up Vessel if the vessel has not yet obtained the Operating Licence), or (b) Approval-in-Principle Letter for Licensing of a Local Vessel (if the vessel has not yet obtained the Certificate of Ownership and Operating Licence). For (b), upon receiving the Maritime Radio (Local Vessel) Licence, the licensee is required to replenish photocopies of the thereafter obtained Certificate of Ownership and Operating Licence to the Authority. If the licensee fails to observe or comply with this requirement, the Authority may take action including not to renew the licence;
    - (ii) Hong Kong identity card(s) or passport(s) of the vessel owner(s);
    - (iii) Business Registration Certificate and Certificate of Incorporation (if applicable) if the vessel is owned by a company;
    - (iv) The document confirming that a contract has been made with an Accounting Authority recognised by the Office of the Communications Authority (OFCA) for settling all communication charges if the station is intended to be use for public correspondence (see information note [OFCA I236](#) for the list of accounting authorities recognised by OFCA); and
    - (v) Radio operator certificate of the person(s) responsible for operating the radio equipment comprised in the ship station, if applicable.
  - (b) Shore station –
    - (i) Business Registration Certificate and Certificate of Incorporation (if applicable) of the yacht club, marinas, etc. at which the station is established; and
    - (ii) Radio operator certificate of the person(s) responsible for operating the radio equipment comprised in the shore station, if applicable.
  - (c) Portable station –
    - (i) Hong Kong identity card or passport of the applicant; and
    - (ii) Radio operator certificate of the applicant.

5. The required supporting documents may be uploaded following the instruction if the application is submitted online or submit by any of the following methods.

6. Payment can be made by cash, cheque or EPS. For payment by cheque, please make the crossed cheque payable to "Office of the Communications Authority". Payment methods –
  - (a) In person to Licensing Office of OFCA, you may pay by cash, crossed cheque or EPS.
  - (b) If application is submitted online or by post, fax or e-mail, you may send a crossed cheque by post to the Licensing Office of OFCA.
7. If the application is approved, the licence will be sent to you by post.
8. The opening hours are 8:30 am to 12:30 pm and 1:30 pm to 5:45 pm Monday to Friday. The office will close on Saturday, Sunday and Public Holidays.
