Unless it is specified by the applicant, an authorisation letter issued more than eighteen months will not be accepted.

- 5. The name and address of the applicant will be used as the name and address of the Licensee.
- 6. The applicant is required to produce the HK Identity Card or Passport for inspection. However, OFCA will also accept copy of the above document provided the applicant accepts that sending copy of the document is at the applicant's own risk.
