 - (b) H.K. Identity Card or passport of the responsible person(s) of the club stated in Part A
 - (c) H.K. Identity Card or passport of the supervisor(s) of the amateur station of the club stated in Part B
 - (d) ASL and/or ATO of the supervisor(s) of the amateur station of the club stated in Part B

- 9. The licence, when granted, will be issued in the registered name of the club. Hence the person(s) responsible for the club shall also be the person(s) responsible to ensure that all the licensing conditions are complied with.
