

申請航空器電台牌照 Application for Aircraft Station Licence

填寫本表格前，請你閱讀以下資料和在通訊事務管理局(通訊局)網頁(<http://www.coms-auth.hk>)的「航空器電台牌照申請指引」。

- 擬在香港民航處註冊的航空器上管有、設置及維持或使用無線電通訊電台作無線電通訊用途的人士，須領有航空器電台牌照。
- 航空器電台牌照的牌費為每年港幣 150 元。
- 申請時需要提交以下證明文件：
 - 由香港民航處簽發的航空器註冊證明書副本。
 - (i) 如航空器屬香港特別行政區永久居民或中國公民擁有：
 - 航空器擁有人的香港身份證或護照副本。
 - (ii) 如航空器屬公司擁有：
 - 有效商業登記證副本；及
 - 公司註冊證明書副本（如適用）。
 - 由香港民航處簽發的航空器無線電裝置許可證副本。
(注意：呈交的商業登記證副本必須包括機印部份，即顯示有繳費日期，收條號碼及繳付的款項。如未能呈交所有證件，申請將不獲處理。)
- 填妥的申請表格，請以下列方式提交：

- 接受以現金、支票或「易辦事」付款。如以支票付款，請劃線並註明抬頭人為『通訊事務管理局辦公室』。付款辦法：
 - 如親自前往通訊辦牌照組，接受以現金、「易辦事」或劃線支票付款；
 - 如經互聯網、郵遞、傳真或電郵提交申請表格，可郵寄劃線支票至通訊辦牌照組收。
- 如申請獲得批准，牌照將會經由民航處轉交給你。
- 辦公時間為星期一至五上午八時三十分至下午十二時三十分及下午一時三十分至下午五時四十五分。星期六、日及公眾假期休息。

Please read the information below and the “Guidelines for Application for Aircraft Station Licence” in the Communications Authority’s (CA’s) website (<http://www.coms-auth.hk>) before completing this application form.

1. An Aircraft Station Licence should be obtained before a person possesses, establishes and maintains or uses a radiocommunications station for radiocommunications on board an aircraft registered by Hong Kong Civil Aviation Department.
2. The annual licence fee for an Aircraft Station Licence is HK\$150.
3. The following documents are required to support this application:
 - (a) Copy of the Certificate of Registration of the aircraft issued by the Hong Kong Civil Aviation Department.
 - (b) (i) If the Aircraft is owned by a permanent resident of the HKSAR or a Chinese citizen :
 - Copy of the Hong Kong Identity Card (HKID) or passport of the owner.
 (ii) If the Aircraft is owned by a company:
 - Copy of the valid Business Registration Certificate; **AND**
 - Copy of Certificate of Incorporation (if applicable).
 - (c) Copy of the Approval of Aircraft Radio Installation issued by the Hong Kong Civil Aviation Department.

(Attention: Copy of the Business Registration Certificate submitted must include the bottom part with a machine-printed column showing the date of payment, the receipt number and the amount paid. Application with insufficient supporting document will **not** be processed.)
4. Please submit the completed application form by any of the following methods:

5. Please submit the supporting documents by any of the following methods:
 - (a) In person or by post to Licensing Office of OFCA;

 - (c) By e-mail to license.mob@ofca.gov.hk.
6. Payment can be made by cash, cheque or EPS. For payment by cheque, please make the crossed cheque payable to "Office of the Communications Authority". Payment methods:
 - (a) In person to Licensing Office of OFCA, you may pay by cash, EPS or crossed cheque;
 - (b) If application is submitted online or by post, fax or e-mail, you may send a crossed cheque by post to Licensing Office of OFCA.
7. If the application is approved, the licence will be given to you via Civil Aviation Department.
8. The opening hours are 8:30 am to 12:30 pm and 1:30 pm to 5:45 pm Monday to Friday. The office will close on Saturday, Sunday and Public Holidays.

Notes about Personal Data

1. The provision of personal data by means of this application form is voluntary. If you do not provide sufficient information, OFCA may not be able to process your application.
 2. The personal data provided by you will be used by OFCA for processing your application made in this form.
 3. The personal data you provide by means of this form may be disclosed to other government departments/agencies in connection with the assessment of your application.
 4. You have a right of request for access and correction with respect to personal data. Your right of access includes the right to obtain a copy of your personal data provided by this application form, though a charge may be levied on obtaining such information.
