Annual Report on Programming Commitment of HK Television Entertainment Company Limited

(To be submitted on or before 31 March each year)

To Communications Authority

Pursuant to Condition 16.1 of the Domestic Free Television Programme Service Licence, HK Television Entertainment Company Limited ("HKTVE" or the "Licensee") hereby submits:-

- a) a report on Local Productions¹ provided in the previous calendar year 2016 ending 31 December has complied with the Licensee's Proposal i.e. eight hours of Local Productions per week within 24 months from the launch of the integrated Chinese channel;
- a report on First-Run Programmes² provided in the previous calendar year 2016 ending 31 December has complied with the Licensee's Proposal i.e. seven hours of First-Run Programmes per week within 12 months from the launch of the integrated Chinese channel;
- c) a report on high definition (HD) television programmes provided in the previous calendar year 2016 ending 31 December has complied with the Licensee's Proposal i.e. HKTVE has proposed to offer most programmes on its integrated Chinese channel in HD format; and
- a report on the Independent Productions Fund for the development and acquisition of independent local productions, which included drama series, variety shows, talk shows documentaries and reality shows.

A. Report on Local Productions

For the period from 31 March 2016 (the launch of the integrated Chinese channel) to 31 December 2016 (the "Relevant Period"), HKTVE's regular broadcasting of Local Productions (without accounting for repeats) has vastly surpassed the Licensee's commitment to broadcast 8 hours of Local Productions per week. The following is the breakdown of regular Local Productions broadcast by HKTVE during the Relevant Period:-

¹ For the purpose of this report, "local productions" refer to programmes produced locally and appealing to local viewers, irrespective of whether they are partly or wholly station-produced, commissioned, collaborated, or joint-ventured programmes but shall not include Government-supplied programmes (e.g. RTHK programmes). The "wholly of Hong Kong origin" content in respect of the PPRs can be counted towards the fulfilment of the local production requirement.

D. Report on Independent Productions Fund

The Licensee submits that a HK\$300 million fund ("Independent Productions Fund") had been set up for the development and acquisition of independent local productions, which included drama series, variety shows, talk shows, documentaries and reality shows.

As at 31 December 2016, the Licensee has partnered with many renowned directors, creative talents, independent producers and new generation directors through the Independent Productions Fund for the production and/or acquisition of locally produced television programmes which demonstrated originality, creativity, production and content quality.

In addition, the Licensee's integrated Chinese channel, ViuTV 99 channel, provided the perfect platform for the independent producers and new generation directors to bring their productions to the public. For the Relevant Period, over 35 programme titles broadcast by HKTVE (mainly comprise of variety programmes and experimental programmes) were produced or acquired through the Independent Productions Fund.
